Before me this date personally appeared Sosnowski, Carl 4710 who being first duly sworn deposes and says that on 28 day of March, 2007 (year), at 201 SE 6th St 7810 Fort Lauderdale Flori (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On the above date and time, I was assigned to courtroom 7810, Judge Siegel presiding, in reference to an unruly in-custody prisoner (Bradley). (Bradley) has been a problem throughout all his previous proceedings and additional security is always requested. At approximately 1150 hours, while court was in session, Judge Siegel pronounced sentencing and (Bradley) stood up and began yelling and flailing his arms in denial. Court Deputy Vargas #13269 immediately responded to (Bradley's) side and attempted to gain control and secure him in his seat. At that point, (Bradley) although chained in the front was able to reach around (Vargas) with his arms and pin him in a compromising position. I immediately responded and commanded (Bradley) to release (Vargas) and sit down. He refused to comply and I displayed my Electronic Control Device (ECD) (Taser) and warned (Bradley) verbally three times. During that time (Vargas) was able to defeat (Bradley's) hold. (Bradley) continued to disregard my commands and I deployed the (ECD) (Taser) striking (Bradley) in the upper chest area. (Bradley) then complied with the I swear the above statement is correct and true to the best of my knowledge and belief.
