On the listed date and time the Arrestee/ Mr. Bellamy was observed traveling south on the 200 block of NW 11 Ave heading towards W. Broward Blvd. We then observed Mr. Bellamy appear to want to make contact with us by waving both his hands at us.

We stop the vehicle and approached Mr. Bellamy and asked him if he needed the police for any assistance. Mr. Bellamy answered the question by stating "No I was only giving you the bird". I then asked Mr. Bellamy, "Do you mind if I search you?" Mr. Bellamy stated "go ahead, no problem".

I began my search with his right front pocket and retrieved a bundle of what appeared to be "crack" cocaine wrapped in clear cellophane. I immediately detained him in handcuffs and Ofc. Stewart used his field VALTOX solution to test the substance and it was VALTOX tested positive for Cocaine. The Cocaine was weighted at approximately 3.6 grams. I advised Mr. Bellamy that he was under arrest.

The Cocaine was placed into FLPD evidence.
